A pancake breakfast following St. Ignatius Mass is held every 4th Sunday (April 26th), a shared fellowship with our host congregation, Ravenna UMC.



Board Minutes Summary, March 12, 2009

(Edited; for complete minutes, see Secretary.)

Meeting was called to order at 7:05 p.m. at Delia Vita's house. Dignity prayer was read. All board members were present.

Minutes were read.

M/M/S/C: To approve the February 5, 2009 meeting minutes as submitted.

Vice President's report (Michael Linden)

- Possible presiders: Michael asked for help from the board in contacting two possible presiders: Pat C. and Thomas A.
- Membership: Michael has contacted the Gay/Straight Alliance of Seattle U., Gonzaga U., and St. Martin's U. so that Dignity/Seattle can possibly do activities together with them as a group.
- Facebook site: Created Facebook profile using Dignity/Seattle. Networked our Facebook group with other Facebook groups such as the one in Washington D.C., New York, San Francisco, etc.
- Cell phone collection: There are at least three organizations which participate in the old cellphone collection drive: Phoneraiser, Ecophones and G.R.C. recycling. They recommend that you don't leave them in a collection box or they might get stolen. We should collect as many cell phones as we can on an individ-

- ual basis and give them to Michael at Dignity. We need to collect at least ten cell phones at a time to get reimbursed. We should get the word out at the Mass that we're starting to collect them, as well as used inkjet cartridges.
- Conference call: There was a conference call on Monday 3/9 between 6:00 and 7:00 p.m., which included 25 people. National Convention in San Francisco: If there's someone we want to sponsor on a chapter-wide basis we should do so during early registration which is \$250 - this will save us some money. There is also a national convention scholarship which can be applied for and needs to be done so by April 1st. There is also a priest scholarship fund for people in religious orders. Bring small items to San Francisco for the online auction. Website: There are big updates to the website: there is extra space for individual chapters. Rating of the Chapter: Mark Matson asked all chapters how we would rate ourselves from 1-10 on morale, growth, financial footing, etc. Michael rated our group at 6.5.
- We could use Craigslist for all our events postings.
- Announcement: Bailey-Boushay is in financial crisis due to state funding cuts and they might close or decrease their social services. We may want to donate to Pride Breakfast proceeds to Bailey-Boushay.

The Board decided to stay with Multifaith Works and to investigate Bailey-Boushay to see if it will stay afloat as a substitute for Verbena.
- National Convention: The Board needs to put out an inquiry for all applicants for sponsorship to the National Convention on a local basis and decide to share money with all those going.
